While the table is informative, please add a column indicating the outcome or resolution of each debate/session (if known), as this will help the reader trace legislative impact.

#### 1.2. Reviewer 2

Reviewer:

The sentence "It should be noted that parts of the official debates of the First Assembly were lost during its bombardment..." needs a citation or supporting historical evidence. Consider adding the source of this claim to strengthen reliability.

The authors state "Library searches and reviews of available Persian sources revealed no independent and comprehensive study devoted to this subject." This claim of novelty requires stronger justification: please add information on search strategy, inclusion/exclusion criteria, and years covered.

The phrase "constitutionalists interpreted it as a triumph of popular sovereignty" would benefit from citing specific contemporary commentaries or press reactions to substantiate this interpretation.

To improve clarity for an international readership, please consistently present both calendars (e.g., "January 28, 1907 [12 Dhu al-Hijjah 1324 AH]").

The sentence "Among these, the Quchan girls' affair set parliament and government at odds and elevated the matter into a national issue" should briefly mention how it shaped later women's rights discourse, connecting it to the study's broader aim.
